COUNTIEFIET BILLS:

SWINE FLU ALERT:

COURT DOCUMENTS: The ranking of New Hartford Town Court is 125th in the state out of 1200 courts. It generates 10% of revenue for the state. The 2008 total amount of monies collected was \$464,000 and the net for the Town of New Hartford was \$202,000. The majority of this sum comes from criminal cases not traffic. The New Hartford crimes are higher than State Police and Oneida County Sherriff's, due to the large commercial area covered. These statistics are based on the number of residents in the Town (21,000) and Village (2,300).

OLD SOUTH STREET CEMETERY: More bones have been found at the High School and the Presbyterian Church has been notified. They are responsible for the remains and burial of these bones. Dr. Tom Christ was on site and excavated the bones.

OFFICER RETIREMENT:

Officer D. Edward Schmidt will retire on 7/31/09 and there will be a retirement luncheon at the Ramada Inn in his honor. Commissioners requested that a gift certificate to Café Del Bono's be sent to Officer Schmidt from the Police Commission.

CPTED:

Chief Philo advised the Commission members that the Security Evaluation of all Town buildings is almost complete. The Highway dept. Court, Butler Hall is completed. The Parks Dept. and Senior Center will be completed soon. The Town Board has received a copy of the report for Butler Hall.

IMPACT V GRANT:

The grant for the Warrant Officer expired on 6/30/09 and has been renewed.

2010 BUDGET:

Chief Philo advised that he is working on the 20210 Budget and will keep the Commission members advised of the progress. The Town is in a fiscal stress right now but the Board Budget Committee is working hard to overcome the problems.

CHIEF'S REPORTS:

ACO VEHICLE:

There are 130,000 miles on the Animal Control vehicle. This could cause a major maintenance issue in the future. If this vehicle cannot be replaced through the purchase of a new vehicle, then a lease possibility will be looked into.

CASES:

A male was arrested in Main recently who formerly lived in New Hartford. Officer Richard Salamone got the confession from the individual that sealed the case for the Maine investigators. This individual was recently murdered while in jail in Maine.

BURGLARY CASES:

The District Attorneys office has been working for 5 years on an organized crime connection in the county. Several cases in New Hartford have now been closed due to the investigation.

NUISANCE ABATEMENT LAW:

The law is being put into effect in the Town and Village. Recent locations are 42 Slusser Ave and 25-27 Clinton Road. Chief Philo advised that the landlords are working with the police department to correct the tenants who are causing problems.

COMMISSION REPORTS:

Commissioner Hughes advised that ATV's are on Elm and Hamilton Streets and that the patrols are helping.

Park Dog Run is working very well. This has produced residents to make sure they have their dogs licensed.

Commissioner Hughes asked if the Elm St. Park is receiving evening security especially at the Splash Pad when not manned.

Commissioner Spellman requested that a letter or contact with headquarters be made with the Outback Rest. Due to increase alarms.

The Police Budget has been submitted with a personnel increase of 3%. Equipment budget is down.

Investigator Officer:

Officer Peter Colburn has been promoted to Investigator on 9/14/09 and Jason Frieberger is now a full-time officer as of 9/14/09.

Oneida County Civil Service Commissioner:

Recently John Talerico was appointed Commissioner of the Civil Service Dept. at Oneida County. Chief Philo has met with the new Commissioner, and had a productive conversation with him.

CHIEF'S REPORTS & COMMUNICATIONS:

Nuisance Abatement Law:

Chief Philo advised that nuisance abatement letter had been sent regarding 58 ½ Genesee St and the landlord has responded. There have been several felony arrests by the Drug Task Force at this location. The department is also looking at 32 Pearl St and a house on Oneida St.

A Nuisance Abatement letter was sent to the owner of 89 Oakdale Ave. South and this owner has evicted the tenants. The house is up for sale.

Holding landlords responsible is the object of the law and it is working.

Supplemental Patrols:

A Town Board member has questioned the Supplemental Patrol at the Marque Cinema. The Cinema had requested extra patrols after there was an incident in another city and the home office requested the patrol for an unknown time. In the past a supplemental patrol that was requested for a short time has not had Board approval.

The Commissioners requested that a letter be sent to Councilwoman Christine Krupa and Village Mayor Donald Ryan to attend the next monthly meeting for an open discussion regarding their concerns and comments of the Supplemental Patrol.

New Administration:
