PETITION FOR ZONING AMENDMENT  
PURSUANT TO ARTICLE XIV OF THE  
TOWN OF NEW HARTFORD ZONING CODE

The undersigned Petitioners who together own more than fifty percent (50%) of the property included within the Planned Development Park District located along Woods Highway in the Town of New Hartford, hereby Petition the Town Board to amend the text of the Planned Development Park District found in Section 118 of the Town of New Hartford Town Code as follows:

Repeal the text currently found in Section 118-39(D)(7)(b) of the Town Code of the Town of New Hartford and replace the text with the following: "Retail services when such limited use occupies no more than 20 % of the PDPD acreage owned, controlled or developed by the Applicant."

The purpose of the text change requested by this Petition is to clarify that these "limited uses" are allowed within the PDPD as stand-alone structures rather than only by incorporation into buildings or structures containing other uses allowed in the PDPD. The increased clarity and flexibility allowed by this language would help encourage development in this PDPD which is the only PDPD in the Town of New Hartford at the present time. Retaining the "20% requirement" will also insure that the primary goal of the PDPD will continue to be achieved.






